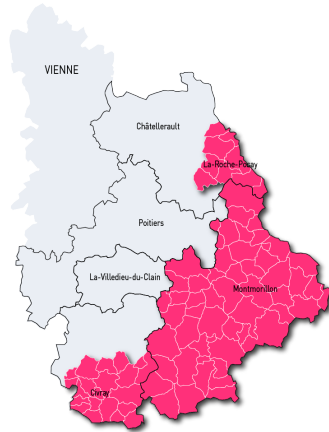


WHY ARE WE CHANGING ?

The new waste management service was implemented from 2022 on 84 municipalities

Anché, Brux, Chaunay, Romagne, Valence-en-Poitou et Voulon, the year 2024 corresponds to the implementation of the last 6 municipalities to have joined the trade union perimeter in 2022, the objective in this sector is to make changes from January 2025.

Faced with environmental issues, the constant increase in the TGAP (General Tax on Polluting Activities) and the various laws, the goal is clear : **to reduce waste generation reach 23% and reach 65% recycling by 2025.**

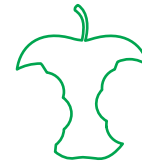

WHAT'S CHANGING ?



→ the generalization of **collection in individual bins (90% of users) or less frequently in PAC* (10% of users)**

*(Point d'Apport Collectif/ Collective input point)



→ **adaptation of the frequency and the calendar of collection** corresponding the reduce of waste's production.



→ implementation of **a new individual billing rate : la Redevance Incitative**



→ reinforced support **for sort and reduction of waste** (composters, sorting facilitation...)

TOMORROW'S EQUIPMENTS

WARNING : DO NOT USE BEFORE THE 1ST OF JANUARY 2022 !

The collection in **individual chipped bins** : one black for non-recoverable waste (dumped in **bags**) and one yellow for recycling waste (except glass) and papers (dumped in **bulk**). Bins are equipped with chips to record the number of times the black bin has been put into collection. So the goal is to **reduce it waste's production** and **take out the black bin only if it's full !**



INDIVIDUALS CHIPPED BINS
(90% OF USERS)



Number of people in the house	Volume of Residual Household Waste Bin	Volume of recyclable paper and packaging
1 to 2 persons	120 L	180 L
3 to 4 persons	180 L	240 L
More than 5 persons	240 L	360 L

or in **Collective input point**, accessible with the waste pass : a column for non-recoverable waste (dumped in **bags**) and a column for recycling waste (except glass) and papers (dumped in **bulk**).

In an exceptional way, other equipment can be proposed for technicals reasons (red bag, bins with key).

LA REDEVANCE INCITATIVE, AN INDIVIDUAL INVOICE

How is it working ?

Nowadays, production of waste is not taken into account in the calculation of the fee. Tomorrow, a home producing less waste and sorting correctly will pay less than a home whose is not sorting. Tomorrow, the Redevance Incitative will be calculated as water or electricity, with a fixed portion and a variable portion.

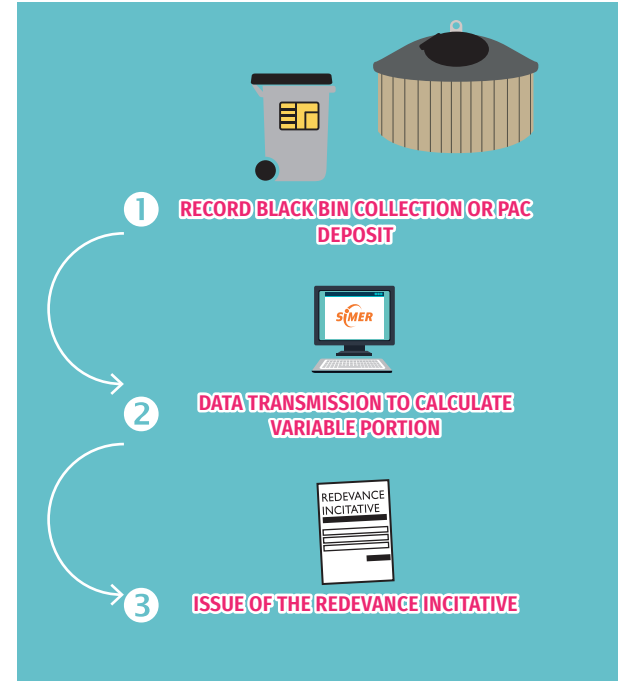
FIXED PORTION

- It include the subscription at Public service for waste prevention and management : collection and treatment of household waste and recycling wastes ; collection in recycling center ; sorting center, composting platform).
- A proportionate share with a defined number of raised or deposits



VARIABLE PORTION

It is calculated based on the number of timethe black bin is collected or the number of black bag deposits in a collective input point.
